PURPOSE

The purpose of the tuition discount is to diversify the student body, attract out-of-state students and South Carolina State University legacy prospective students (any person whose parent or grandparent is an alumnus) to South Carolina State University by assessing in-state tuition to such out-of-state students hereinafter referred to as Tuition Discount.

POLICY STATEMENT

The South Carolina State University Tuition Discount Program is defined as the assessment of in-state tuition to certain groups of out-of-state students. Specifically, the Program may be applied to out-of-state students from the states of North Carolina and Georgia upon verification of the said state residency and who hold a grade point average of 3.0 or greater on a grading scale of 4.0. Additionally, the Program may be applied to South Carolina State University legacy students not residents of South Carolina or qualifying under the terms defined above for residents of North Carolina and Georgia. Such legacy students must hold a grade point average of 3.0 or greater on a grading scale of 4.0. The University will calibrate the grade point average requirement for different grading scales to be comparable to that of a 3.0 on a 4.0 grading scale.
